#### Re: SCHOOL FEES - 2024

Dear Parents/ Guardians and Sponsors

Parkview Junior School is a compulsory fee-paying public school.

We are dependent on school fees in order to function properly. Our fees and fee policy are reviewed on an annual basis.

We thank all who have paid their fees regularly during 2023. By doing so you enable the school to provide a quality education to our learners.

At the AGM held on 26<sup>th</sup> October 2023, a quorum of parents approved that the school will remain a compulsory fee-paying school.

In terms of Section 39 of the South African Schools Act 84 of 1996, you are therefore liable to pay school fees.

The following 2024 fees, fee structure and resolutions, were adopted at the Annual General Meeting of 26th October 2023.

We advise that the annual school fees per learner for the 2024 school year will be:

Grade 1-3 for R29,100 Grade R for R 31,150

Compulsory Book Fee R500 - Due by 31st December 2023 (Non-Refundable once 2024 books are issued).

School fees are payable in advance and if fees are not paid in advance, they are due in 10 equal monthly instalments

of: Grade 1 – 3: R2,910 per month Grade R: R3,115 per month

(the amount is less if deposit paid)

Payments commence on 1st January 2024, ending 31st October 2024.

#### **PAYMENT OPTIONS**

The following payment options are available:

- (a) In cash to the school.
  - A cash deposit fee will be charged to the parent/guardian's account
  - Amounts over <u>R500</u> must be deposited directly into the school's bank account and email proof of payment <u>finance@parkviewjunior.co.za</u>
- (b) By Direct Deposit into the school bank account <u>EFT or cash deposit</u> (please note that cash deposit fees will be charged to the parent/guardians account)
- (c) By debit order in which event parents are requested to complete Annexure B Debit order form. This must be completed annually.

#### **DISCOUNTS**

- 1. Parents who settle their accounts in full, <u>on or before 31 December 2023</u>, will be entitled to a discount of R1,400 per learner, <u>this applies for Gr R to Gr 3</u>.
- 2. Parents who settle their accounts in full <u>by 31 January 2024</u> will be entitled to a discount of R1,200 per learner, this applies for Gr R to Gr 3.

Please see below for requirements if full settlement of accounts is done.

- Amounts must be paid directly into the school's bank account
- Email Proof of Payments to the school accounts department finance@parkviewjunior.co.za
- Cash deposit fee (where applicable) will be charged to the Parent/Guardian's school fees account.

#### APPLICATION FOR EXEMPTION FULL, CONDITIONAL OR PARTIAL EXEMPTION OF SCHOOL FEES

Please contact the office to arrange collection of the necessary form in January 2024.

The written application for exemption/partial/conditional exemption of school fees is to be submitted before **28 February 2024**.

Should the application not be successful, an appeal can be made to the School Governing Body (SGB) and Gauteng Department of Education via the SGB.

#### **UNDERTAKING TO PAY SCHOOL FEES**

The annexed "Undertaking to Pay School Fees" which follows, must be completed and returned to school by Friday, 17 November 2023.

#### POLICY REGARDING FEES WHEN LEAVING THE SCHOOL MID-YEAR

Should you withdraw your child from Parkview Junior School during the year, we require 1 month's fees as notice. This means the following, if:

- 1. Monthly payments made you are required to pay 1 month's fees following the month of notice given. E.g. If notice is given in July (7 months attended) and you leave within a month of giving notice you are required to settle 8 months of fees.
- 2. Full fees settled at the beginning of the year your reimbursement will be calculated on 10 months as if you paid monthly. i.e annual fee /10 x number of months not attended (less 1-month notice fee if applicable) E.g. Notice given in August and leave within 1 month of notice (number of months attended 8+1 months fees notice) the calculation will be as follows: R29,100/10x1 = R2,910 refund.
- 3. Learners who leave during the 4<sup>th</sup> term will be liable for a full years' school fees.
