## **Re: SCHOOL FEES - 2026**

Dear Parents/ Guardians and Sponsors

Parkview Junior School is a **compulsory fee-paying public school**.

We are dependent on school fees in order to function properly. Our fee policy and fees are reviewed on an annual basis.

We thank all who have paid their fees regularly during 2025. By doing so you enable the school to provide a quality education to all our learners.

At the Annual General Meeting (AGM) held on 4 November 2025, a quorum of parents approved that the school will remain a compulsory fee-paying school.

In terms of Section 39 of the South African Schools Act 84 of 1996, you are therefore liable to pay school fees.

The following 2026 fees, fee structure and resolutions, were adopted at the AGM..

We advise that the annual school fees per learner for the 2026 school year will be:

**Grade 1-3 for R31,200**  
**Grade R for R 33,300**

**Compulsory Book Fee R550 - Due by 31<sup>st</sup> December 2026 (Non-Refundable once 2026 books are issued).**

School fees are payable in advance and if fees are not paid in advance, they are due in **10 equal monthly instalments**

Payments commence on 1<sup>st</sup> January 2026, ending 31<sup>st</sup> October 2026.

## **PAYMENT OPTIONS**

The following payment options are available:

- (a) In cash or by card to the school.
  - Bank charges will be charged to the parent/guardian's account
  - Amounts over **R500** must be deposited directly into the school's bank account and email proof of payment [finance@parkviewjunior.co.za](mailto:finance@parkviewjunior.co.za)
- (b) By Direct Deposit into the school bank account – EFT or Cash deposit (please note that cash deposit fees will be charged to the parent/guardians account)
- (c) By debit order - in which event parents are requested to complete Annexure B - Debit order form. This must be completed annually.

## **DISCOUNTS**

1. Parents/Guardians who settle their accounts in full, on or before 31 December 2025, will be entitled to a discount of R1,800 per learner, this applies for Gr R to Gr 3.
2. Parents/Guardians who settle their accounts in full by 31 January 2026 will be entitled to a discount of R1,400 per learner, this applies for Gr R to Gr 3.
3. Parents/Guardians who settle their accounts via 10 successful consecutive debit orders From January 2026 will be eligible for a R1,000 discount in October.

Please see below for requirements if full settlement of accounts is done.

- **Amounts must be paid directly into the school's bank account**

- **Cash deposit fee (where applicable) will be charged to the Parent/Guardian's school fees account.**

## **APPLICATION FOR EXEMPTION FULL, CONDITIONAL OR PARTIAL EXEMPTION OF SCHOOL FEES**

Please contact the office to arrange collection of the necessary form in January/February 2026.

The written application for exemption/partial/conditional exemption of school fees is to be submitted before **27 February 2026**.

Should the application not be successful, an appeal can be made to the School Governing Body (SGB) and Gauteng Department of Education via the SGB.

## **UNDERTAKING TO PAY SCHOOL FEES**

The annexed "Undertaking to Pay School Fees" which follows, must be completed and returned to school by Friday, 28 November 2025.

## **POLICY REGARDING FEES WHEN LEAVING THE SCHOOL MID-YEAR**

Should you withdraw your child from Parkview Junior School during the year, we require written notice and one month's fees as notice.

This means the following, if:

1. Monthly payments made – you are required to pay 1 month's fees following the month of notice given. E.g. If notice is given in July (7 months attended) and you leave within a month of giving notice you are required to settle 8 months of fees.
2. Full fees settled at the beginning of the year – your reimbursement will be calculated on 10 months as if you paid monthly. i.e – annual fee /10 x number of months not attended (less 1-month notice fee if applicable) E.g. Notice given in August and leave within 1 month of notice (number of months attended 8+1 months fees notice) - the calculation will be as follows:  $R31,200/10 \times 1 = R3,120$  refund.
3. Learners who leave during the 4<sup>th</sup> term will be liable for a full years' school fees.
